## Event Security and Crowd Safety Survey of Surrounding High Schools and the Novato Police Department

Surrounding high schools with existing stadium lights and evening events were contacted in order to provide additional clarity regarding their level of security needs and specific campus security commitments. Additionally, campuses were asked if they have experienced security issues from the stadium lights on their campuses in the past. The Novato Police Department was also contacted to gather input regarding the potential for the project to increase the need for police protection in the area. Table 1 includes a summary of the existing security requirements at the surrounding campuses with existing stadium lights and evening events, including: San Rafael High School, Justin-Siena High School, Petaluma High School, Casa Grande High School, Piner High School, and Rancho Cotate High School, as well as input regarding security from the Novato Police Department. The response from the Novato Police Department is from Police Captain Knox based on a summary of comments received from staff.
