Approval of the ICOC Regular Meeting Minutes for March 18, 2020

Mike Woolard reminded the committee to turn in their Form 700 form for 2019 if they have not done so previously.

The following changes to the ICOC Committee were announced: Sylvia Barry and Brigit Nevin accepted a third term to the ICOC, and Judy Adison-Hight has accepted her second term. All three were to be approved by the Board of Trustees at the June 16, 2020 Board meeting.

It was also announced that Greg Coté would be stepping down as committee member as of June 30, 2020, as he no longer meets the geographic requirements to serve on the committee. Mike thanked him for his three years of service to the Measure G Citizens' Oversight Committee, and his dedicated work on the annual report sub-committee.

Bond Facilities Project Update – Summer 2020 Projects

Presentation focused on the Summer 2020 projects, as well as new projects that are in the programming phase for Summer 2021.

For Novato High School, construction progress was discussed for the Center for the Arts, the Center for the Sciences, and for the Athletic Field Complex. The Athletic Fields project, although at primary completion, is closed due to Covid 19 restrictions. Mike shared two videos featuring still photography and drone aerial footage to highlight the construction at Novato HS. The construction status for the STEM Building and the Performing Arts Center at San Marin High School was highlighted next, and a video showing both buildings' progress was presented.

Other 2020 projects included the A/C installation at Loma Verde ES; sewer work at Lu Sutton and Loma Verde ES; the roof replacement project at the Novato HS Old Gym and Olive Ave. warehouse; the completion of the Food and Nutritional Services (FANS) warehouse buildout; the progress-to-date on the Grounds, Maintenance and Operations (GMO) warehouse on C-Street, and the 1:World District-wide Chromebook project.

Summer 2021 Planning and Programming was discussed. These projects include a Synthetic Turf Sports Field project and a campus-wide Exterior Finish Replacement at San Marin High School; Lynwood ES site modernization and new kitchen project; and an Olive ES site modernization and construction of a new administration building.

Judy Adison-Hight had questions regarding plans for landscaping and any sidewalk hardscaping at the new GMO facility on C Street. Mike outlined the City's property line along State Access Road from Nave Drive to the SmartTrain station. Sylvia Barry asked for an update on Chromebooks from the 1: World project. Yancy Hawkins explained the additional increased time of support now given by Google for these Chromebooks, thereby extending the useful life cycle of devices from 5 years to 6 years, effectively increasing the 1: World program potential. Yancy also explained that with the onset of remote learning required due to Covid-19, the District was in the top 25% of districts in the state able to dive into remote learning due to the Measure G 1: World program.

Erich Mesenburg inquired regarding areas of concern for the remainder of the Measure G program given changes in the District's operational budget due to Covid 19 impacts and the defeat of the renewal of the District's

Parcel Tax. Yancy Hawkins spoke to potential program impacts vis a vis any future closing of a campus, and would bring to the committee information regarding such if the Board ever made that decision.
