Derek Knell, Director of Staff Housing Development, introduced Brookwood Partners and James Traber, legal counsel to the Board of Trustees. Brookwood Partners provided an overview of their services related to Education Workforce Housing. After conducting research on potential consultants, staff determined that Brookwood Partners would be the best fit for the District. A finalized contract and initial scope of work will be brought to the Board for approval at a future meeting. An Education Workforce Housing Board Workshop is also in the planning stages.

Installation of the equipment will take place in the summer or 2025 as there is a 52-week lead time for equipment.
